1. Call to Order

Closed Session was announced at 10:36am by Kathleen Kane. Defense Counsel provided an overview to the Committee while Marc supplied additional information on behalf of the City. Marc Zafferano then recused himself due to the jurisdiction he represents being a party to the claim. Jeff and Shawn also left the meeting (all left at 11:45 am) while the Committee then deliberated.

4. Claims Discussion / Settlement Authority

San Bruno Police Litigation, DOL: 10.22.13, Claim: ABGV20547A1

Marc Zafferano returned to the call at 12:04 pm for the remainder of the meeting.

TPA Claims Administration - York Claims Administration Contract Renewal 5.

Jill noted the original contract has already been approved and it is simply an extension to the original. The good news is that the original pricing for the claims administration piece was fair and the renewal extension continues with the same 3% cost escalator. Some housekeeping items such as our SF address and YORK's new address updates are the only other changes and are not material. Discussion took place regarding the subrogation recovery services York can do for a 20% fee. We have opted to retain in house and John Saelee leads those efforts. Additionally, we also help with the subrogation matters that are under deductible. As of April 30th, 2017 we have been engaged in 325 subrogation efforts and we have recovered \$1,106,066 for the group. Included in the packet are the original and the amendment agreement for review. Kathleen called for questions and asked if staff would like a motion. Jill declined stating she will note that the Committee accepts the contract extension, as presented. Kathleen asked if anyone had a concern. None were raised.

6. Legal Counsel Defense Firms

a. Defense Counsel Appointment

Jill briefed the Committee on a member's request for a defense attorney to be added to the panel. She noted this is in response to a formal request from a member and noted that this attorney's background and specialization is in Employment Practices and Labor which the pool's liability MOC doesn't cover. The attorney is well qualified in her areas of specialization. Staff is not making a recommendation but is asking the Committee to discuss and render a decision given the unique request. Heather proposed to decline the addition as there is no need to have an Employment Practice Attorney on the panel. Kathleen asked if there was a policy regarding who goes on the panel. Jill confirmed there is not, other than it being the Committee's responsibility in maintaining a defense panel. Discussion ensued in determining whether scenarios exist where an attorney with this specialization would be utilized as well as whether this is the right attorney to select (given no comparisons). Marc said he doesn't see a reason to add her now based on a coverage denial. It is an odd circumstance. Kathleen said we can reevaluate later. Kathleen directed staff to relay the decision of the group which is to refrain from adding the attorney to the panel at this time.

Kathy asked if she can leave the remainder of the meeting since no other actions are on the table. Kathleen agreed about the time and suggested ending the meeting soon and informed the committee to review the York Stewardship Report and touch base with Jill should they have any questions. Kathleen asked if there was any other business that has to be conducted on this call at this point.

b. Rate Discussion

Jill noted agenda item 6b and told the Committee she can send the decrypted version to the Committee if requested. Jill has been fielding numerous rate increase requests. A suggestion was to include attorney rates when recommending defense options after a suit is received. Kathleen mentioned that she is speaking for the entire committee in saying that is extremely good information to differentiate. Kathleen stated she also would like to see a billing history from YORK on these attorneys when selecting one to defend a matter. This will assist with the overall assessment on who may be the best fit for each engagement.
